Submittal for Approval

A. Scope

The following guidelines are provided to clarify the submittal requirements for approving a reflector according to Section 1097 **Reflectors** of the Standard Specifications for Road and Bridge Construction.

B. Procedure

When submitting a reflector to the Department, the following shall be included with the material:

- 3 each of the reflector,
- The specific product brand name,
- Technical Data Sheet,
- A signed letter stating the subject material will not be changed without written notification to the Department,
- Contact person's name, title, address, email address, and phone number, and
- Acknowledgement by Company form <u>BMPR 101</u>.

The sample and submittal information shall be sent to:

When a sample is submitted, it will be tested for Sealing, Heat Resistance, Dimensions, Load Resistance and Specific Intensity in accordance with Section 1097.

C. Recertification

Recertification of all Reflectors is required every two years or when a change is made to the manufacturing process.
