## Submittal for Approval

### A. Scope

The following guidelines are provided to clarify the submittal requirements for approving an iron casting and or replacement reflector according to Article 1096.01 **Raised Reflective Pavement Markers** of the [Standard Specifications for Road and Bridge Construction](#).

### B. Procedure

When submitting an iron casting or replacement reflector to the Department, the following shall be included with the material:

- The specific product brand name,
- Technical Data Sheet,
- A signed letter stating the subject material will not be changed without written notification to the Department,
- Contact person's name, title, address, email address, and phone number, and
- Acknowledgement by Company form [BMPR 101](#).

### C. Recertification

Recertification of all Raised Reflective Pavement Markers is required every five years or when a change is made to the manufacturing process.
