## **NBI Subscription Service Announcement 20200313**

### **IDOT Bridge Inspection Training Classes – March and April 2020**

In keeping with current IDOT procedures regarding the Department's response to the ongoing coronavirus situation, the IDOT Bureau of Bridges and Structures is utilizing a screening process to determine if any individuals registered for upcoming bridge inspection classes should be excluded due to health concerns.

If you are registered for one or more of the bridge inspection classes listed below and haven't previously submitted the attached form, you must do so by the date indicated below. **This includes IDOT personnel.** If the form is not submitted by the date noted below, your registration will be cancelled.

- 1) **IDOT Bridge Inspection Calibration Class** March 16–17, 2020 in Springfield, IL
  - **March 13, 2020**
- 2) **NHI-130056: Safety Insp. of In-Service Bridges for PE's** March 23-27, 2020 in Schaumburg, IL
  - **March 20, 2020**
- 3) **IDOT Bridge Inspection Calibration Class** March 30–31, 2020 in Schaumburg, IL
  - **March 27, 2020**
- 4) **FHWA Intro. to Element Level Bridge Insp.** April 22 – April 23, 2020 in Springfield, IL
  - **April 20, 2020**

Please note, if screened out of either of the IDOT Bridge Inspection Calibration Classes, the following applies:

- 1) IDOT will automatically grant up to a six (6) month extension for NBIS Program Manager and Team Leader Certifications expiring between March and October 2020;
- 2) IDOT will automatically register those screened out of the above classes for the October 26-27, 2020 IDOT Bridge Inspection Calibration Class in Springfield, IL; &
- 3) IDOT will explore additional IDOT Bridge Inspection Calibration Classes in 2020 to accommodate any overflow

If the above bridge inspection classes were not required to maintain or be qualified for NBIS Program Manager or Team Leader Certification in the State of Illinois, IDOT would cancel. Depending on how events unfold in the next few days, cancellation may be required.
