




CONFERENCE FLOOR PLAN

A. Bradley Mims serves as the director of DOT's Office of Small and Disadvantaged Business Utilization. Director Mims's role is to ensure the secretary's small business policies and goals are implemented fairly, efficiently and effectively. He also advises the secretary in implementing wealth creation initiatives as part of DOT's Equity Action Plan.

Mims has served as a government and private transportation professional for over 40 years. Before OSDBU, Mims was appointed as the Federal Aviation Administration deputy administrator, where he led multiple initiatives including Diversity Equity Inclusion & Accessibility, competition, workforce development, historically Black colleges or universities, Minority Serving Institution, and Unmanned Aircraft Systems/drones. He led a special panel for staffing for the Air Traffic Organization, airport initiatives regarding funding and Airport Improvement Program



BREAKOUT SESSION 1 WEDNESDAY, FEB. 21, 9:45 - 11 A.M.

Multi-modal Transportation Plans – More than Planes, Trains, and Automobiles | Doing Business | Plaza A

This session promises to be guite comprehensive, covering the diverse and extensive multi-modal transportation systems in Illinois. From public transportation to highways, railways, waterways, and airports, Illinois seems to have it all. The mention of navigable waterways connecting to both the Atlantic Ocean and the Gulf of Mexico underscores the state's strategic geographical advantage for transportation and commerce.

The involvement of a multidisciplinary team in planning such complex transportation systems is crucial. Community outreach ensures that the plans align with the needs and preferences of the people they serve. Strategic planning helps in setting long-term goals and priorities, while environmental planning ensures that development is sustainable and minimizes negative impacts. Data collection and analysis are fundamental for informed decision-making, helping planners understand current trends and anticipate future needs.

By addressing these various disciplines, the session aims to provide a holistic understanding of multi-modal statewide transportation planning, highlighting the interconnectedness of different modes of transportation and the importance of collaboration across disciplines for effective planning and implementation. - **BJ Murray**, Section Chief, Aviation and Marine Transportation, Office of Planning & Programming, IDOT BJ Murray has been with IDOT since 2001. Prior to coming to work at IDOT, he spent 13 years with a consulting firm preparing transportation planning and environmental studies as well as business development activities. Murray is a graduate of MacMurray College where he obtained a Bachelor of Science degree. He also holds a Bachelor of Arts in Management from the University of Illinois.
- Janel Veile, Section Chief, Planning Services, Bureau of Planning, Office of Planning & Programming, IDOT Janel Veile serves as the Planning Services Section Chief at IDOT's Bureau of Planning. Her section is responsible for developing many of the statewide multi-modal transportation plans, including the Long-Range Transportation Plan, Freight Plan, Public Transportation Plan, Rail Plan, and Active Transportation Plan. She has worked at IDOT in various roles for over 22 years. She holds a Master of Environmental Studies and is a Doctor of Public Administration candidate specializing in policy analysis and program evaluation at University of Illinois at Springfield.
- DeAnna Smith, Rail Planning Manager, Bureau of Planning, Office of Planning & Programming, IDOT DeAnna Smith has been with the Department for 37 years. She graduated from Northern Illinois University with a Bachelor of Arts degree. She serves on the Peoria Passenger Rail Leadership Team, the Illinois State Freight Advisory Council, and the Mid-America Freight Coalition. Smith is the Project Manager for the 2023 Illinois State Rail Plan Update.
- Adam Gabany, Intermodal Planning Unit Chief, Bureau of Planning, Office of Planning & Programming, IDOT In his capacity as Intermodal Planning Unit Chief, Adam Gabany is responsible for Illinois' Freight Plan, Competitive Freight Program, State Freight Advisory Council, and Active Transportation Planning. The focus of his position is to advance a safe. efficient, reliable, resilient and sustainable multimodal system that supports Illinois' competitive position as a global hub, grows the economy, and enhances equity and quality of life for Illinois residents. Gabany has worked in a variety of roles over his 18-year career with IDOT. He holds an MBA and has an engineering background.
- Hannah Martin, Transit Planning Manager, Bureau of Planning, IDOT Hannah Martin began her position as Transit Planning Manager in IDOT's Bureau of Planning in September 2023. Coordinators also serve as job skill trainers and liaisons to local highway construction contractors and trade unions.

Davis-Bacon Act Compliance Principles | Rules & Regs | Plaza B

The Davis-Bacon Act and related legislation apply to contractors and subcontractors working on federally funded or assisted contracts in excess of \$2,000 for the construction, alteration or repair (including painting and decorating) of public buildings or public works. On such projects, contractors and subcontractors must pay their laborers and mechanics employed under the contract no less than the local prevailing wages and fringe benefits for corresponding work on similar projects in the area. The Davis-Bacon Act directs the Department of Labor to determine local prevailing wage rates. This workshop will discuss topics such as coverage, laborers and mechanics, site of work, truck drivers, apprentices/trainees and helpers, fringe benefits, and computing overtime pay. (1.25 PDH)

- Anne Thomas. Wage and Hour Investigator, U.S. Department of Labor
 - Anne Thomas graduated from Webster University in St. Louis, with a Master of Arts in Human Resources Management and received a Bachelor of Science in Management and Human Resources from Park University in Parkville, Mo. Throughout his career Ward has investigated about every payroll law the Department enforces and has found tens of millions of dollars of back wages owed to workers throughout the state.
