Introduction and Background

As required by 23 CFR § 1300.13, the Illinois Department of Transportation (IDOT) is mandated to submit a Biennial Survey of State Automated Traffic Enforcement Systems. Illinois has enabling legislation that allows automated traffic enforcement systems for Red-Light Cameras (RLC) and Speed Cameras (SC). The Illinois Compiled Statutes that permit these are 625 ILCS 5/11-208.6 and 625 ILCS 5/11-208.8. It should be noted that these systems are only allowed to be used in the following eight Illinois counties: Cook, DuPage, Kane, Lake, Madison, McHenry, St. Clair and Will.

The following is a summary of the state automated traffic enforcement systems survey conducted by Bureau of Safety Programs and Engineering (BSPE) within IDOT. The survey questionnaire was designed to collect information and data from the local jurisdictions and political subdivisions responsible for the administration of RLC and SC systems in Illinois. The survey questions included background information of the agency responsible for administering these cameras (name, location, population, types of camera and equipment), general information on the Federal DOT guidelines, transparency, accountability, and safety attributes. The survey focused on locations, violations, crash statistics, availability of data, procedural information, audits and process for dispute resolution, and post installation safety and operational performance throughout Federal Fiscal Year 2020 (See **Appendix A** for the survey questionnaire, BSPE 727).

Survey Method

In November 2019, BSPE identified 68 potential local jurisdictions and political subdivisions that were responsible for all enforcement related equipment in Illinois, using the Insurance Institute for Highway Safety (IIHS) website: <https://www.iihs.org/topics/red-light-running>. Each identified local jurisdiction and political subdivision was sent the BSPE 727 questionnaire. All 68 local jurisdictions and political subdivisions completed and returned the survey. Only one (Village of Alsip) reported that they have removed their RLCs.

Overall, these **67** jurisdictions/political subdivisions reported **340** locations of RLC intersections. The City of Chicago is the only jurisdiction that has SC road segments. The City of Chicago has **302** SC locations.

Table 1 shows the list of the 67 jurisdictions/political subdivisions and their population size.

Appendix B includes locations of Red-Light Enforcement Cameras in intersection and road Segments in Illinois. **Appendix C** contains specific locations of Speed Enforcement Cameras in intersection and road segments in the City of Chicago. Both appendices include Identification numbers (ID), agency name, road/street, route jurisdiction, intersection or road segment and direction of travel enforced.

Survey Results

The following survey results are divided into four categories: General, Transparency, Accountability, and Safety Attributes. **Table 2** provides frequency and percentage distributions of selected items under the above four categories.

General

- The population size of the **67** local jurisdictions or political subdivisions where the RLCs are installed ranged from 580 in Bedford Park to 2.7 million in the City of Chicago.
- All the RLC equipment are contracted or leased.
- Of the total **67** local jurisdictions and political subdivisions, **39** local jurisdictions and political subdivisions (**58.2%**) are villages and **28 (41.8%)** are considered cities.
- **62** out of **67 (92.5%)** local jurisdictions and political subdivisions reported that they referred to and followed FHWA “Red Light Camera Systems Operational Guidelines” when implementing their automated enforcement system.

Transparency

- **Over 95%** of the local jurisdictions and political subdivisions responded that the placement locations of automated enforcement are publicly available on their website.
- **56.7%** of the local jurisdictions and political subdivisions responded that information on automated enforcement revenue is publicly available on their website.
- **46.3%** of the local jurisdictions and political subdivisions responded that disbursement of enforcement revenue is publicly available on their website.
- **43.3%** of local jurisdictions and political subdivisions indicated that the number of automated enforcement citations issued publicly, are available on their website.
- **Over 88%** of the local jurisdictions and political subdivisions indicated that there was a warning period before citations were issued. About **42%** of the local jurisdictions and political subdivisions **said** they had only two warning periods. Majority of the local jurisdictions and political subdivisions (about **44.8%** percent) indicated that the warning period was **30 days**.

Accountability

- **98.5%** of local jurisdictions and political subdivisions responded that all citations were signed by sworn law enforcement officers.
- **100%** of local jurisdictions and political subdivisions reported that there was a process in place to dispute resolution.
- **65.7%** of local jurisdictions and political subdivisions indicated that their automated enforcement program was audited. Among those audited, **52.2%** said that their automated enforcement program was audited annually.

Safety Attributes

- Over **98.5%** of the **67** local jurisdictions and political subdivisions reported that the traffic and safety data (engineering & crash) were utilized to determine placement of automated enforcement platforms.
- Over **94%** of the **67** local jurisdictions and political subdivisions reported that they analyzed traffic safety data to determine their automated enforcement's impact on safety elements (i.e. crashes, speed, etc.).
- Approximately **95.5%**, **64** out of **67** local jurisdictions and political subdivisions, reported they evaluated their post-installation safety and operational performance. Over **82%** of them reported they evaluated their post-installation safety and operational performance annually.
